

**CASCADE TOWNSHIP ANNUAL MEETING AGENDA

- CLERK TO CALL THE MEETING TO ORDER AT 8:15 PM

- 4) TREASURER JOE VROMAN TO READ THE TOWN FUND SUMMARY FOR 2010

- 5) SET TIME OF DAY FOR NEXT ANNUAL TOWNSHIP ELECTION. (DATE MUST BE 2ND TUESDAY OF MARCH, WHICH WILL BE MARCH 13, 2012. SUGGEST TIME FOR ELECTIONS FROM 5:00 TO 8:00 PM AS THIS YEAR. START MEETING AT 8:15PM.
