

APRIL 2, 2007---THE REGULAR MEETING OF THE CASCADE TOWNSHIP BOARD WAS HELD AT THE CALVARY EVANGELICAL FREE CHURCH MEETING ROOM AT 6:00PM. PRESENT WERE, SUPERVISORS, ARLEN HEATHMAN, HAROLD ATKINSON AND CHAIRMAN LENNY LAURES AND CLERK\TREASURER JOE VROMAN.

MOTION BY HEATHMAN TO APPOINT LAURES AS CHAIRMAN OF CASCADE TOWN BOARD FOR THE COMING YEAR, SECONDED BY ATKINSON, ALL VOTED IN FAVOR.

THE MINUTES FROM THE MARCH 5TH MEETING WERE READ BY VROMAN, AND WERE APPROVED ON A MOTION BY ATKINSON, SECONDED BY HEATHMAN, ALL VOTED IN FAVOR.

SUPERVISOR ATKINSON MADE A MOTION TO PAY THE JOINT POWERS BILL OF \$9,689.72 FOR THE PAST MONTH, SECONDED BY HEATHMAN, ALL VOTED IN FAVOR.

A MOTION TO PAY THE REMAINING BILLS WAS MADE BY LAURES, SECONDED BY ATKINSON, ALL VOTED IN FAVOR TO PAY THE TOTAL BILLS OF \$14,265.96.

TREASURER JOE VROMAN GAVE THE FINANCIAL REPORT AT THE MEETING. BEGINNING BALANCE WAS \$256,912.32, WHICH INCLUDED THE MARCH CHECKING INTEREST OF \$961.86, INCOME SINCE THE LAST MEETING, OLMSTED COUNTY 4TH QUARTER AGGREGATE FEE OF \$2,180.70. CHECKS WRITTEN TOTALED \$14,265.96, WHICH INCLUDED CASCADE'S SHARE TO JOINT POWERS BOARD, FOR AN ENDING CHECKING BALANCE OF \$242,646.36. THE MOTION TO APPROVE THE TREASURERS REPORT WAS MADE BY LAURES, SECONDED BY ATKINSON, ALL VOTED IN FAVOR.

AT 6:15PM, DEPUTY VAL COE DID NOT ATTEND THE MEETING DUE TO ILLNESS.

AT 7:00PM, MIKE SHEEHAN, OLMSTED COUNTY HIGHWAY ENGINEER ATTENDED THE MEETING TO PROVIDE INFORMATION ON THE PRELIMINARY DESIGN AND RIGHT OF WAY STUDY ON COUNTY ROAD 104 (60TH AVENUE NW) FOR THE UPCOMING OPEN HOUSE FOR THE PUBLIC ON APRIL 10TH AT THE ROCHESTER ATHLETIC CLUB. DISCUSSION FOLLOWED.

MOTION BY ATKINSON TO INSTALL A FIRE HYDRANT AT THE CASCADE MAINTENANCE SHOP FOR USE BY ORONOCO AND FARMINGTON TOWNSHIPS, SECONDED BY HEATHMAN, ALL VOTED IN FAVOR.
