

JULY 9, 2007---THE REGULAR MEETING OF THE CASCADE TOWNSHIP BOARD WAS HELD AT THE CALVARY EVANGELICAL FREE CHURCH MEETING ROOM AT 6:00PM. PRESENT WERE, SUPERVISORS, ARLEN HEATHMAN, HAROLD ATKINSON AND CLERK\TREASURER JOE VROMAN. CHAIRMAN LENNY LAURES WAS ABSENT. SUPERVISOR HAROLD ATKINSON ACTED AS CHAIRMAN. ALL IN ATTENDANCE RECITED THE PLEDGE OF ALLEGIANCE.

AT 6:00PM, DEPUTY VAL COE WAS PRESENT AT THE MEETING. NO UNUSUAL CIRCUMSTANCES.

THE MINUTES FROM THE JUNE 4TH MEETING WERE READ BY VROMAN, AND WERE APPROVED ON A MOTION BY HEATHMAN, SECONDED BY ATKINSON, ALL VOTED IN FAVOR.

SUPERVISOR ATKINSON MADE A MOTION TO PAY THE JULY JOINT POWERS BILL OF \$12,529.15 FOR THE PAST MONTH, SECONDED BY HEATHMAN, ALL VOTED IN FAVOR.

A MOTION TO PAY THE REMAINING BILLS WAS MADE BY HEATHMAN, SECONDED BY ATKINSON, ALL VOTED IN FAVOR TO PAY THE TOTAL BILLS OF \$116,064.29.

TREASURER JOE VROMAN GAVE THE FINANCIAL REPORT AT THE MEETING. BEGINNING BALANCE WAS \$163,589.07, WHICH INCLUDED THE JUNE CHECKING INTEREST OF \$597.55, INCOME SINCE THE LAST MEETING, 2007 1ST QTR AGGREGATE TAX OF 534.05, OLMSTED COUNTY 1ST HALF TAX PAYMENT OF 281,500.65. CHECKS WRITTEN TOTALED \$116,064.29, WHICH INCLUDED CASCADE'S SHARE TO JOINT POWERS BOARD, FOR AN ENDING CHECKING BALANCE OF \$329,025.43. MOTION TO APPROVE THE TREASURERS REPORT WAS MADE BY ATKINSON, SECONDED BY HEATHMAN, ALL VOTED IN FAVOR.

AT 6:30PM, DIANA CHUTE OF 330 LOWRY COURT NW APPEARED BEFORE THE BOARD TO REQUEST THAT HER CULVERT BE CLEANED OUT AND AT THE SAME TIME SHE WOULD PAY FOR A CULVERT EXTENSION OF APPROXIMATELY 6 FOOT WITH APRONS BE ADDED TO EACH SIDE OF HER DRIVEWAY. DISCUSSION FOLLOWED ON THIS SUBJECT. THE TOWN BOARD WILL GET TOGETHER WITH MS. CHUTE AND DO AN ON SITE INSPECTION OF THE PROBLEM AND DECIDE AT THAT TIME WHAT IS TO BE DONE ABOUT THE CULVERT PROBLEM.
