

**JUNE 4, 2007**---THE REGULAR MEETING OF THE CASCADE TOWNSHIP BOARD WAS HELD AT THE CALVARY EVANGELICAL FREE CHURCH MEETING ROOM AT 6:00PM. PRESENT WERE, SUPERVISORS, ARLEN HEATHMAN, HAROLD ATKINSON AND CHAIRMAN LENNY LAURES AND CLERK/TREASURER JOE VROMAN. ALL IN ATTENDANCE RECITED THE PLEDGE OF ALLEGIANCE.

AT 6:00PM, DEPUTY VAL COE WAS PRESENT AT THE MEETING.

THE MINUTES FROM THE MAY 7TH MEETING WERE READ BY VROMAN, AND WERE APPROVED ON A MOTION BY ATKINSON, SECONDED BY HEATHMAN, ALL VOTED IN FAVOR.

SUPERVISOR ATKINSON MADE A MOTION TO PAY THE JUNE JOINT POWERS BILL OF \$14,051.01 FOR THE PAST MONTH, SECONDED BY HEATHMAN, ALL VOTED IN FAVOR.

A MOTION TO PAY THE REMAINING BILLS WAS MADE BY HEATHMAN, SECONDED BY ATKINSON, ALL VOTED IN FAVOR TO PAY THE TOTAL BILLS OF \$21,453.87.

TREASURER JOE VROMAN GAVE THE FINANCIAL REPORT AT THE MEETING. BEGINNING BALANCE WAS \$183,911.34, WHICH INCLUDED THE MAY CHECKING INTEREST OF \$713.73, INCOME SINCE THE LAST MEETING, NONE. CHECKS WRITTEN TOTALED \$21,453.87, WHICH INCLUDED CASCADE'S SHARE TO JOINT POWERS BOARD, FOR AN ENDING CHECKING BALANCE OF \$162,457.47. MOTION TO APPROVE THE TREASURERS REPORT WAS MADE BY ATKINSON, SECONDED BY HEATHMAN, ALL VOTED IN FAVOR.

AT 6:15PM, GARY PEDERSEN FROM TCPA AND ATTORNEY BILL RYAN ON BEHALF OF ARLETTA ROLLINS, FOR A 0.6 ACRE METES AND BOUNDS REQUEST. AFTER SOME DISCUSSION BY ALL, A MOTION BY HEATHMAN TO APPROVE THE REQUEST WITH THE LAND IN QUESTION BEING ATTACHED TO THE PROPERTY TO THE EAST. THIS ACTION WAS SECONDED BY ATKINSON, ALL VOTED IN FAVOR.

AT 6:30PM, CPA LLOYD JOHNSON AND JOY HARRIS PRESENTED AN INDEPENDENT AUDIT REPORT FOR THE YEAR ENDED DECEMBER 31, 2006 AND WERE FOUND TO BE IN CONFORMITY WITH ACCOUNTING PRINCIPLES GENERALLY ACCEPTED IN THE UNITED STATES OF AMERICA.

MEETING ADJOURNED AT 8:30PM ON A MOTION BY LAURES, SECONDED BY ATKINSON, ALL VOTED IN FAVOR. JOE VROMAN, CLERK
