

FEBRUARY 4, 2008---THE REGULAR MEETING OF THE CASCADE TOWNSHIP BOARD WAS HELD AT THE CALVARY EVANGELICAL FREE CHURCH MEETING ROOM AT 6:00PM. PRESENT WERE CHAIRMAN LENNY LAURES, SUPERVISORS ARLEN HEATHMAN AND HAROLD ATKINSON AND CLERK/TREASURER JOE VROMAN. ALL IN ATTENDANCE RECITED THE PLEDGE OF ALLEGIANCE.

AT 6:00PM, DEPUTY VAL COE WAS PRESENT AT THE MEETING. THERE WAS DISCUSSION ON CAR BURGULARIES.

THE MINUTES FROM THE JANUARY MEETING WERE READ BY VROMAN AND WERE APPROVED ON A MOTION BY ATKINSON, SECONDED BY LAURES, ALL VOTED IN FAVOR.

SUPERVISOR ATKINSON MADE A MOTION TO PAY THE JANUARY JOINT POWERS BILL OF \$23,026.13, SECONDED BY HEATHMAN, ALL VOTED IN FAVOR.

A MOTION TO PAY THE REMAINING BILLS WAS MADE BY ATKINSON, SECONDED BY HEATHMAN, ALL VOTED IN FAVOR TO PAY THE TOTAL BILLS OF \$25,326.10.

TREASURER JOE VROMAN GAVE THE FINANCIAL REPORT AT THE MEETING. BEGINNING BALANCE WAS \$271,999.85, WHICH INCLUDED THE JANUARY CHECKING INTEREST OF \$781.47, AND INCOME DEPOSITED IN JANUARY FROM, FILING FEES 4.00, LGA REFUND 582.79, 2007 FINAL TAX SETTLEMENT 3,701.77 FOR A TOTAL JANUARY DEPOSITS OF 5,070.03. CHECKS WRITTEN TOTALED \$25,326.10, FOR AN ENDING CHECKING BALANCE OF \$246,673.75. MOTION TO APPROVE THE TREASURERS REPORT WAS MADE BY ATKINSON, SECONDED BY HEATHMAN, ALL VOTED IN FAVOR.

A MOTION BY ATKINSON TO VOTE IN FAVOR FOR L.G.A. TO DISSOLVE, THIS WAS SECONDED BY HEATHMAN, ALL VOTED IN FAVOR.
