Agenda Announcement and Review

Approval of Minutes: The minutes from April 17, 2018 were briefly reviewed and discussed. A motion to approve the minutes without changes was made by Commissioner Friederichs and Commissioner Adolphson seconded the motion. All voted in favor and the motion passed.

Call to Audience: There was a brief discussion on how to best handle an addendum to meeting minutes. It was decided in the future to reference documents if they already exist on the Township website.

CUP Maintenance review: None scheduled

Study Session: Roger Ihrke was unable to attend in person but did call in to provide an update of rezoning of North Quarry request from Mathy Construction. There is nothing new from neither Mathy Construction nor Olmsted County Engineers. Other details of the rezoning request and timeline were briefly discussed.

Continuing Business:

Reconciliation and Review: Olmsted County Subdivision and Platting Ordinances (2017) vs. Current Cascade Township Subdivision Ordinances (2003): The previously unreviewed articles were discussed. Review of Articles I, II, VI, VII, VIII, X, XI and XII were completed. Articles III, IV and V require more changes and review. As previously approved by the Township Board, Cascade Clerk Rudquist will consolidate changes.

Update from Town Board: Supervisor Laures and Commissioner Adolphson provided an update on the topics of the Township Board meeting of May 14th, 2018.

Round-the-Table: There was a brief discussion of quarry-related flying rock and mitigations. The next meeting is scheduled for June 19th, 2018.
